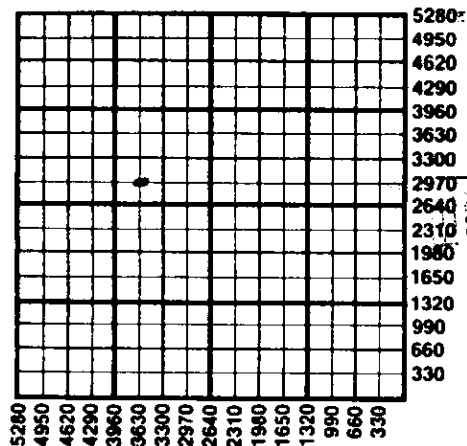

This card void if drilling not started within six (6) months of date received by K.C.C.

### Important procedures to follow:

1. Notify District office before setting surface casing.
2. Set surface casing by circulating cement to the top.
3. File completion forms ACO-1 with K.C.C. within 90 days of well completion, following instructions on ACO-1, side 1, and including copies of wireline logs.
4. Notify District office 48 hours prior to old well workover or re-entry.  
Prior to filing Intent, prepare a proposed plugging plan in case well is D & A, then obtain approval of plan when calling district office prior to setting surface pipe.
5. Submit plugging report (CP-4) to K.C.C. after plugging is completed.
6. Obtain an approved injection docket number before disposing of salt water.
7. Notify K.C.C. within 10 days when injection commences or terminates.
8. If an alternate 2 completion, cement in the production pipe from below any usable water to surface within 120 days of spud date.
