Bailed 4 sacks cement on bridge plug. Cut bad thread off 4 1/2" casing. Perforated at 1200', 900' & 315'. Ran tubing to 1200' & pumped 35 sacks cement & 100# hulls. Pulled to 900' & pumped 35 sacks cement & 100# hulls. Pulled to 315' & pumped 40 sacks cement & 50# hulls. Pulled out & pumped 100 sacks cement down 4 1/2" casing, Did not circulate. Ran 210' of 1" tubing down 8 5/8" casing. Pumped 60 sacks cement, circulated to surface. Ran 1" tubing down 4 1/2" casing to 210' & pumped 15 sacks cement to surface. Cut surface off 4' below ground.
