- 4. Notify District office 48 hours prior to old well workover or re-entry.
- Prior to filing Intent, prepare a proposed plugging plan in case well is D & A, then obtain approval of plan when calling district office prior to setting surface pipe.
- 6. Submit plugging report (CP-4) to K.C.C. after plugging is completed.
- Obtain an approved injection docket number before disposing of salt water.
- Notify K.C.C. within 10 days when injection commences or terminates.

If an alternate 2 completion, cement in the production pipe from below any usable water to surface within 120 days of spud date.
