Dear Operator:

The enclosed Well Plugging Application forms (CP-1 and KSONA-1), received August 29, 2012, for the above-referenced well are incomplete due to non-compliance with the Kansas Surface Owner Notification Act (KSONA). Unfortunately, these forms cannot be processed without the following corrections because **no election was made designating whether you, as the operator of record, have notified the Surface Owners or whether you prefer KCC to notify them (see highlighted area)**. Although we also received a notification letter addressed to the two Surface Owners residing in Arizona, the signature on this letter is **original** therefore it is unclear whether your intent is for KCC to notify the Surface Owners or whether you just enclosed this original letter in error and intended to send it to them yourself. Please clarify your intent.

If you elect to **notify the Surface Owners yourself**, then you will need to check the box next to the **first certification statement** on the KSONA-1 form, then initial and date beside this change. You **may include a copy** of your letter to the Surface Owners for our records but you are **not required** to do so.

However, if you elect for **KCC to notify the Surface Owners**, then check the box next to the **second certification statement** on the KSONA-1 form, initial and date beside this change, and enclose a check for \$30.00, payable to KCC, in payment of the KSONA-1 Notification Fee. If you desire for your letter to the Surface Owners to be included in KCC's notification to them, please **return your original letter** with these forms.

Additionally, regardless of whether you elect the first or the second certification statement, you will need to line through your previous signature and date signed on the KSONA-1 form and **re-sign and re-date** it due to the update you will have made to this form. This is required in order to meet our legal staff's minimum guidelines in order to approve your well plugging application.

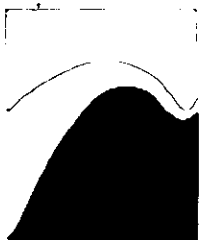

This letter is to notify you that the Conservation Division has received your plugging proposal, form CP-1, for the above well and has reviewed the proposal for completeness. The central office will now forward your CP-1 to the district office listed below for review of the proposed plugging method. **Please contact the district office for approval of your proposed plugging method at least five (5) days before plugging the well, pursuant to K.A.R. 82-3-113(b). If a workover pit will be used during the plugging of the well it must be permitted. A CDP-1 form must be filed and approved prior to the use of the pit in accordance with K.A.R. 82-3-600.**

The Conservation Division's review of form CP-1, either in the central or district office, does not include an inquiry into well ownership or the filing operator's legal right to plug the well. This notice in no way constitutes authorization to plug the above well by persons not having legal rights of ownership or interest in the well.

This notice is void after March 10, 2013. The CP-1 filing does not bring the above well into compliance with K.A.R. 82-3-111 with regard to the Commission's temporary abandonment requirements.
