Ms. Lutz,

I understand that you have submitted plugging applications for the three wells subject to this Penalty Order, which are the Evel A #1, #2, and #5. Upon a request for additions or corrections, you resubmitted the forms. The KSONA-1 forms still indicate that you are requesting the KCC send notice to the surface owner. However, we do not believe this is your intention, because you did not send \$30 for each form (\$90).

We are approving these forms, but the approval is contingent upon your mailing copies of the well plugging applications to the surface owner.

Our records indicate these wells must be plugged by October 11, 2012, pursuant to a recent warning letter. This is a firm deadline. If the wells cannot be plugged by the deadline due to the contractor's schedule, you should provide me with a letter from the contractor including anticipated date that they will plug the well. Thank you for working on reaching compliance in this matter, and please call with any concerns.

This letter is to notify you that the Conservation Division has received your plugging proposal, form CP-1, for the above well and has reviewed the proposal for completeness. The central office will now forward your CP-1 to the district office listed below for review of the proposed plugging method. **Please contact the district office for approval of your proposed plugging method at least five (5) days before plugging the well, pursuant to K.A.R. 82-3-113(b). If a workover pit will be used during the plugging of the well it must be permitted. A CDP-1 form must be filed and approved prior to the use of the pit in accordance with K.A.R. 82-3-600.**

The Conservation Division's review of form CP-1, either in the central or district office, does not include an inquiry into well ownership or the filing operator's legal right to plug the well. This notice in no way constitutes authorization to plug the above well by persons not having legal rights of ownership or interest in the well.

This notice is void after March 26, 2013. The CP-1 filing does not bring the above well into compliance with K.A.R. 82-3-111 with regard to the Commission's temporary abandonment requirements.
