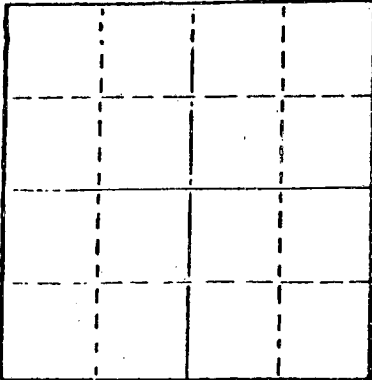

Filled hole with heavy rotary mud from 4,480 ft. (rotary total depth) to 740 ft. Set plug at 740 ft. and cemented with 70 sacks cement. Filled hole with heavy rotary mud from 740 ft. to 270 ft. Set plug at 270 ft. and cemented with 25 sacks cement. Filled hole with heavy rotary mud from 270 ft. to 40 ft. Set solid plug at 40 ft. and cemented totcellar with 10 sacks cement, 5 sacks cement in rat hole.

Plugging operations accomplished utilizing Sun Oil Well cementing pump truck through 4 1/2 inch drill pipe.
