Dear Mr. Hestermann,

As I have previously advised you, a few weeks ago, Jim Hemmen contacted Raven Resources, LLC and informed Raven that paperwork submitted to the Kansas Corporation Commission on the Gebhards 1-35 and 2-35 wells contained incorrect legal descriptions for the wells – the township was incorrectly shown as 12S rather than 11S – and even the lease signs showed the wrong township.

Investigation into the matter shows that the original paperwork filed with the KCC by Crown Consulting reflected the incorrect township. It was a clerical error that continued as the subsequent reports which were submitted to the KCC used the original reports as go-bys.

As per our email correspondence, and included with this letter, Raven is submitting corrected reports – reflecting the Correct Township. Raven has also changed the Lease signs at the entrance to the Gebhards wells. The following corrected reports are submitted herewith (reference is to the pdf numbers from your email of 11/27/2012):


