Shut down washout pump & lines - Release Plug - Displace Plug with 2 1/2 Bbls water. Final Pumping at 300 PSI - Pumped Plug to 1000 PSI - Close Tubing in with 1000 PSI. Good cement returns with 2 1/2 Bbl slurry
