ORDER GRANTING APPLICATION

The above-captioned matter comes on for consideration and determination by the State Corporation Commission of the State of Kansas. Being fully advised in the premises, the Commission finds and concludes that:

1. The application in this docket was properly filed pursuant to the rules and regulations of the Commission and the laws of the State of Kansas.
2. Proper notice has been furnished to all interested parties. No protests were filed.
3. Based on the requirements of the Commission's regulations, the staff of the Conservation Division recommended approval of the application, which seeks authority to commingle production.
4. Estimated current production of the subject well from the **LANSING-KANSAS CITY** source of supply is **4 BOPD** and **7 BWPD**. Estimated current production from the **JOHNSON** source of supply is **3 BOPD** and **4 BWPD**. The total estimated current

production from all sources of supply in the subject well is **7 BOPD** and **11 BWPD**. Applicant seeks authority to produce all sources of supply simultaneously, through the same tubing string.

5. Commingling from the **two** common sources of supply in the manner stated will prevent waste, permit the recovery of oil and/or gas from the respective sources of supply which would otherwise be lost, and protect correlative rights of the royalty owner, applicant, offset operators, and the public generally.

6. Based upon the depth of the perforations in the **JOHNSON** formation of the subject well, the total oil production from the **two** sources of supply shall not exceed **200 BOPD** per day and the total gas production from the **two** sources of supply shall not exceed **50%** of the open flow.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT: **MCCOY PETROLEUM CORPORATION**, a Kansas Corporation, and is, hereby authorized to commingle production from the **LANSING-KANSAS CITY** and **JOHNSON** sources of supply through the same well bore in the well. Such production shall be limited as prescribed in finding number six (6) herein.

Any party affected by this Order may apply, by written petition, for a hearing thereon before the Commission, pursuant to K.S.A. 77-537. Such petition must be filed with the Executive Director of the Conservation Division, Finney State Office Building, 130 S. Market, Room 2078, Wichita, Kansas 67202, within three (3) days following service of this Order. If a hearing is not requested, this Order shall become effective upon the expiration of the three (3) day time period for requesting a hearing.


The Commission retains jurisdiction of the subject matter and the parties for the purpose of entering such further orders as it may deem proper.
