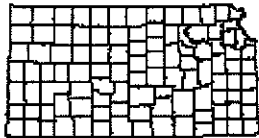

Overview Map

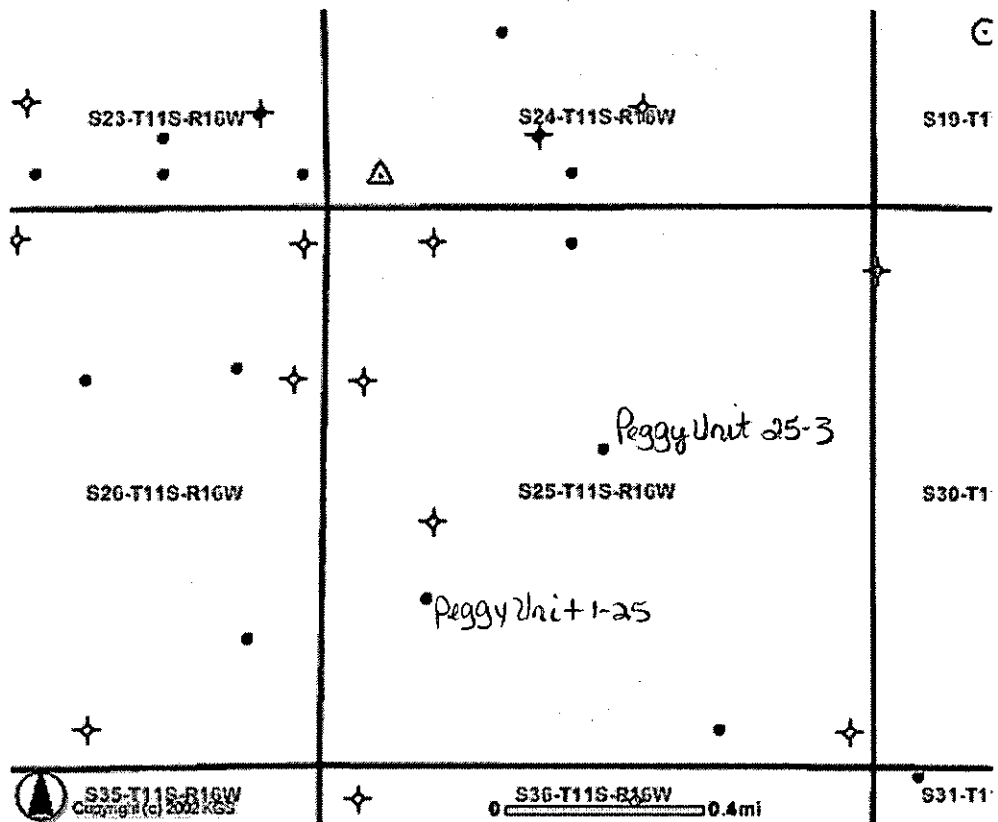

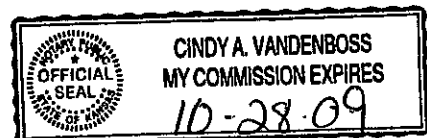

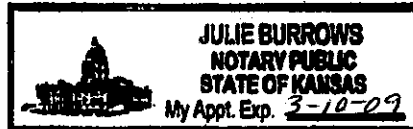
