Dear Randall K. Arnold:

Current Commission Regulation K.A.R.82-3-111 states that an operator must either (1) plug the well or (2) give notice of the temporary abandonment on the prescribed form (CP-111) to the K.C.C. within 90 days after operations have ceased on the well. These measures are prescribed by the K.C.C. to protect the ground water and prevent pollution.

The above well was found as a result of a recent lease inspection. According to our records this well has not been plugged and a CP-111 has not been filed.

Due to the amount of time that we feel that this well has been abandoned a temporary abandonment application will not be approved. This letter serves as notice that the above described well must either be plugged or returned to service within 90 days from the date of this letter. Please contact the Dodge City Office to exercise your option to either plug or return this well to service.

If you wish to contest this action, please send your written request for a formal conference with the district supervisor at the appropriate address. In the event a satisfactory agreement cannot be reached at that time, this matter will be referred to the Central Office Legal Staff for further handling.
