The above well was plugged as follows:

They topped the Dakota at 1210' & bottomed it at 1270'. 1st plug at 1300' with 50 bbls of cement. 2nd plug at 360' with 40 bbls of cement. 3rd plug 40' to 0' with 10 bbls of cement. Then circulated 10 bbls of cement in rat-hole. The cement was pumped through drill pipe with hole full of heavy mud. The cement used was 50/50 Port 32 p/l 2700. The plugging was accomplished by Halliburton Co. The 40' to 0' plug was on a solid bridge.

Amount of Surface Casing: 310' of 8 5/8" cement circulated
