

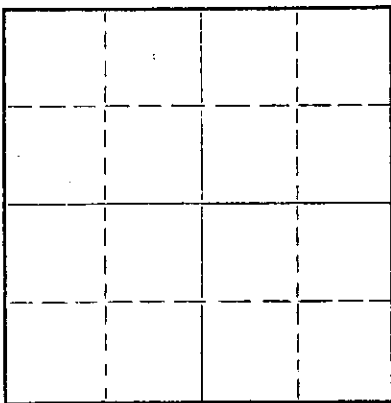

Pumped in 20 sacks of cement @ 600', pulled 5 1/2" casing to 220' and pumped in 20 sacks of cement. Pulled balance of 5 1/2" casing and capped well with 10 sacks of cement.
