Titan squeezed well with 400 # hulls, 10 sacks gel, 50 sacks cement, 10 sacks gel, 100# hulls; released plug and pumped 100 sacks. 60/40 pozmix cement with 6% gel. Maximum pressure was 1000 psi and shut in 600 psi.
