This letter is to notify you that the Conservation Division has received your plugging proposal, form CP-1, for the above well and has reviewed the proposal for completeness. The central office will now forward your CP-1 to the district office listed below for review of the proposed plugging method. **Please contact the district office for approval of your proposed plugging method at least five (5) days before plugging the well, pursuant to K.A.R. 82-3-113(b). If a workover pit will be used during the plugging of the well it must be permitted. A CDP-1 form must be filed and approved prior to the use of the pit in accordance with K.A.R. 82-3-600.**

The Conservation Division's review of form CP-1, either in the central or district office, does not include an inquiry into well ownership or the filing operator's legal right to plug the well. This notice in no way constitutes authorization to plug the above well by persons not having legal rights of ownership or interest in the well.

**This notice is void after May 31, 2014. The CP-1 filing does not bring the above well into compliance with K.A.R. 82-3-111 with regard to the Commission's temporary abandonment requirements.**

Dear Mr. Faulker:

We have processed your plugging applications (CP-1 forms) for the two above-referenced wells. However, please be advised that your proposed plugging contractor, Holman Well Services, LLC of Pampa, TX (#34572) has been deleted from both forms as this contractor is no longer licensed through the KCC. Their license expired June 30, 2013 so you will need to locate another plugging contractor and provide this information to staff in our district office in Dodge City, KS. You may reach them at (620) 225-8888.

Additionally, please be advised that we granted an exception and accepted paper forms for these plugging applications due to the pending legal action on these two wells. However, as your license is currently valid, you will need to submit all future CP-1 and KSONA-1 forms via our KOLAR online filing process. All currently licensed operators are required to comply with electronic filing which took effect April 1, 2013. Please refer to the instructions on the enclosed KOLAR NOTICE: Electronic Filing Required.





The 2009 Legislature passed *House Bill 2032*, known as the *Kansas Surface Owners Notice Act*.
