This letter is to inform you that an additional extension of time in which to close the haul-off pit associated with the May Spicer 2-32 well, that was requested in your letter dated December 2, 2013, has been **denied**.

The original 365 days for closure expired on April 6, 2010 and the granted extension expired on May 13, 2013. 82-3-602 states that no pit permit extension shall be extended beyond six months after the original deadline.

The drilling pits must be closed and the Closure of Surface Pit, form CDP-4, must be filed by May 2, 2014. Failure to close the pit and file the CDP-4 by May 2, 2014, will result in a \$250 penalty for failure to timely close the pit.
