Dear Sir or Madam:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the Goering 10-14-10-11H.

The original 365 days for closure expired on 08/31/2014. This extension will expire on 1/13/2015. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the closure of surface pit form, **but not the time period for filing the waste transfer form (CDP-5).**

*Failure to close the pit or request an additional extension prior to the expiration date shall result in a monetary penalty in accordance with K.A.R. 82-3-602(a). An additional pit extension may be renewed upon request, but **no pit permit extension shall be extended beyond six months after the original deadline.***

Dear Kansas Corporation Commission (KCC),

This letter requests an extension on the due date for the Surface Pit Closure Form for Source Energy MidCon LLC's Goering 10-14-10-11H well. Every effort is currently being made to safely finalize closure of the Goering 10-14-10-11H surface pit. Due to the location of the well, the surface pit was dug deeper and more narrow than usual. The unusual geometry of this pit, paired with increased precipitation this year, resulted in additional time needed for the pit to dry out, and is preventing us from finalizing closure of the pit.

We have contacted a KCC representative, Jon Hill, who witnessed and documented efforts to close the surface pit on location at the Goering 10-14-10-11H site.

Also, we filed for a new NID for this well to be re-dill due to a collapsed lateral. The API was changed from 15-015-23988-01-00 to 15-015-23988-02-00. **Please confirm if we also need to file Pit Closure and Waste Transfer Forms under the Goering 10-14-10-11h 15-015-23988-02-00 API.**
