This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the Schlegel 9 #3H well.

The original 365 days for closure expired on 08/17/2014. This extension will expire on 1/17/2015. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the closure of surface pit form, **but not the time period for filing the waste transfer form (CDP-5).**

Failure to close the pit or request an additional extension prior to the expiration date shall result in a monetary penalty in accordance with K.A.R. 82-3-602(a). An additional pit extension may be renewed upon request, but **no pit permit extension shall be extended beyond six months after the original deadline**.

We are in receipt of the above referenced NOTICE OF VIOLATION dated October 02, 2014, for failure to submit a Form CDP-4 for the Schlegel 9 #3H reserve pit, API: 15-195-22885-01-00, located in the S2S2SESW, 9-T11S-R22W, Trego County, Kansas.

As you know the Schlegel 9 #3H was granted Temporary Abandonment Status by the KCC ("CP-111") on April 30, 2014 so that we might further evaluate the potential utility of the Schlegel 9 #3H wellbore. Best practices amassed over the past 5 years by McElvain and other operators in the area are currently being considered.

Although there is no excuse for my missing the 12 month post spud pit closure deadline, I would like to request a 3 month pit permit extension under (2) of K.A.R. 82-3-602. The extension should provide us time to decide what if we pursue further completion attempts or plug and abandon this wellbore and restore the location. We will keep KCC personnel apprised of our operations. Thank You for your time.
