

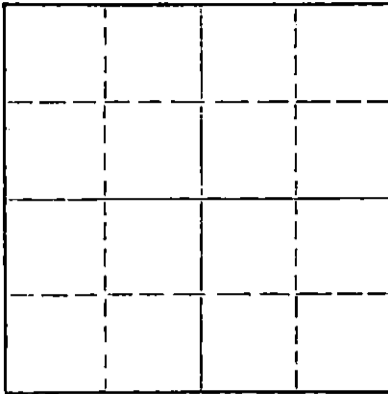

Checked hole to 4485', sanded hole to 4450' and dumped 3 sacks of cement @ 4450' with dump bailer. Pulled 4 1/2" casing, set rock bridge from 260' to 250' and set 1 sack of Gal Seal on rock bridge. Bailed hole to 250' and dumped 25 sacks of cement @ 250'. Mudded hole to 40', set rock bridge to 30' and ran 10 sacks of cement to base of cellar.
