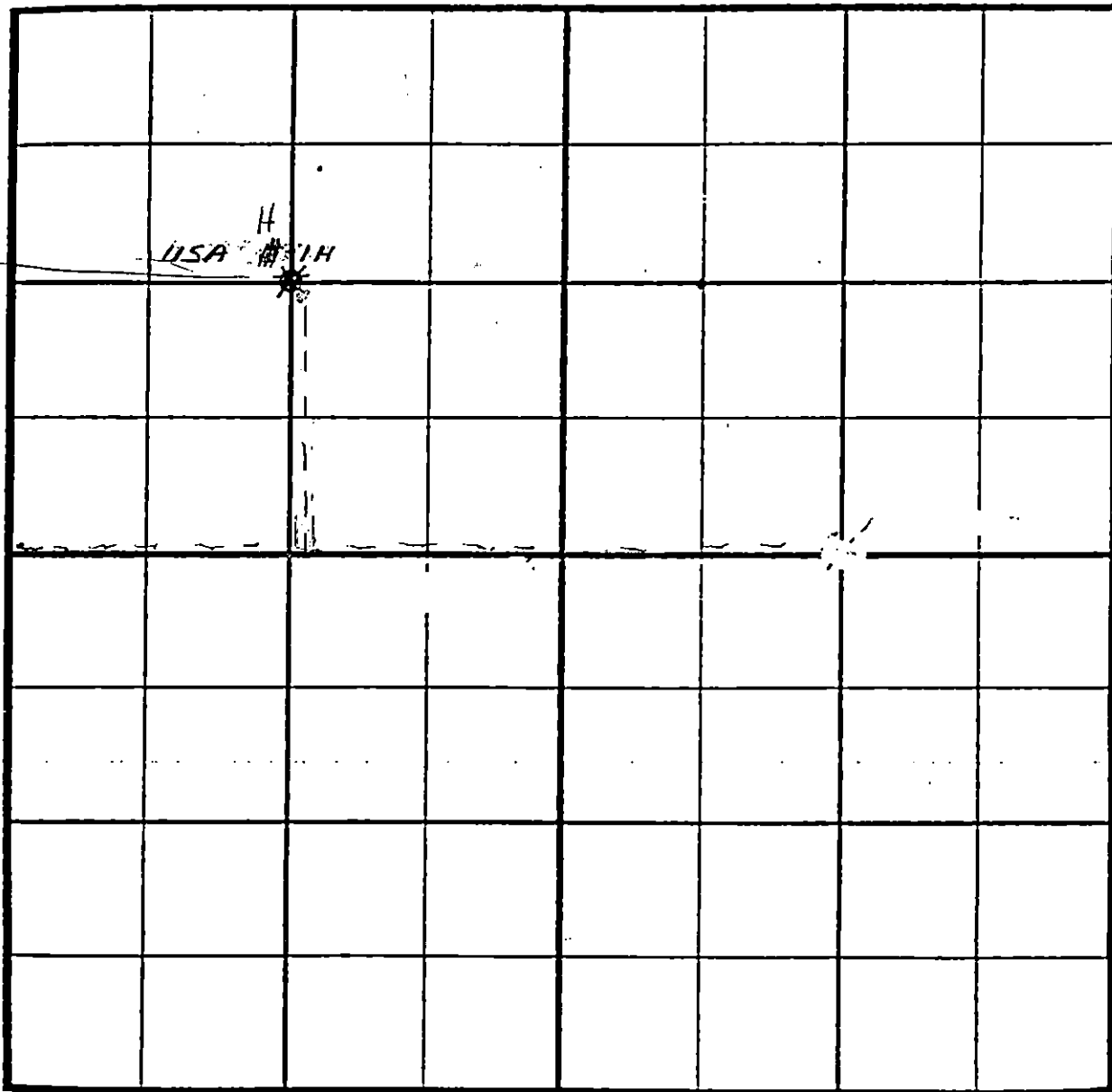
SECTION PLAT
