

No. 2. In the event Buyer and Seller have heretofore entered into a written agreement providing for the purchase and sale of the products mentioned in this order and the period covered by such prior agreement has not expired, then this order shall be considered as made by Buyer and accepted by Seller on the same terms and conditions set forth in said prior agreement and nothing herein contained shall be held in any manner to be a modification of such prior agreement of purchase.

No. 3. Seller represents that the sale of the article or articles referred to herein, and the price therefore and delivery thereof will conform to all applicable federal and state laws, orders, rules and regulations.
