Dumped 1 sx hulls and hull sx in well. Pushed down with cut off 4 1/2" casing. Filled to surface with cement. Cut off 8 5/8" casing 3 1/2' below ground level. Welded a plate on 8 5/8" casing. Covered up hole.
