

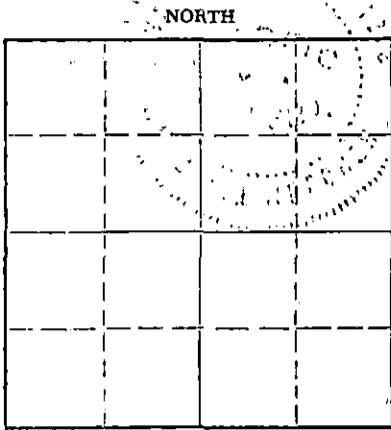

Bailed fluid down to 260', set 10' rock bridge and dumped 35 sacks of cement. Mudded to 40', set rock bridge and dumped 15 sacks of cement.

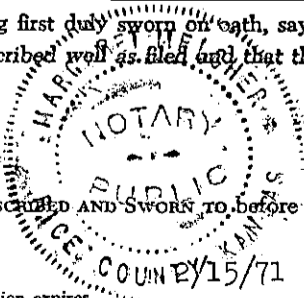
