Allied squeezed well with 4 sacks hulls, 10 sacks gel, 50 sacks cement, 10 sacks gel, 1 sack hulls, released plug and pumped 130 sacks 60/40 pozmix cement with 6% added gel. Maximum pressure was 500 psi and shutin 100 psi.
