Plugging Report

Monday, December 17, 1984

Moved in and rigged up Pratt Well Service's single drum pulling unit. Ran measuring line. Found T.D. @ 685'. Ran $2\frac{1}{2}$ " tubing with rough collar and drilled to 775'. Plugged well with 4 sks. hulls, 20 sks. gel, and 100 sks. cement. Had no circulation. Well went on strong vacuum. Removed tubing.

Tuesday, December 18, 1984

Ran measuring line. Found T.D. @ 684'. Ran 258' of tubing. Well would not circulate. Placed tubing at 550'. Displaced 300 gal. "Flow Check" and cemented w/230 sks. cement. Removed tubing.

Wednesday, December 19, 1984

Ran measuring line. Found T.D. @ 589'. Ran tubing to 250'. Established circulation. Pumped in 200 sks. cement - lost circulation. Pulled tubing to 145' - pumped in balance of cement (30 sks.). Let set 4 hrs. then ran steel line - found top of cement @ 334'.

Thursday, December 20, 1984

Welded 5-1/2" collar in surface casing. Released pulling unit and shutdown until tomorrow to let cement set up.

Friday, December 21, 1984

Ran measuring line. Found T.D. @ 125'. Filled hole to the top with cement. Mr. Steve Durrant and Mr. Bob Metz with the KCC witnessed and approved this plugging.
