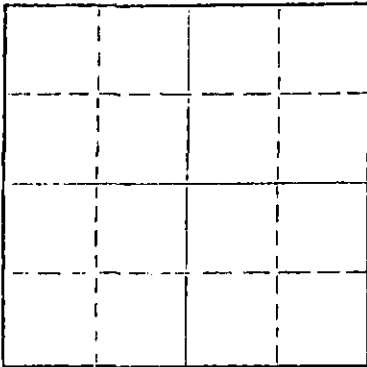

Plugged well with 3 sacks hulls - 10 sacks gel and 100 sacks cement.

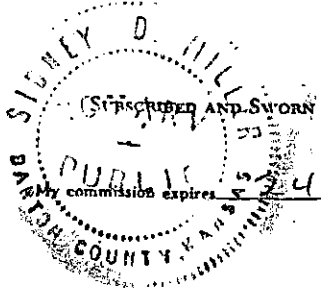
