This letter is to inform you that you have been granted an additional extension of time in which to close the drilling pits associated with the Osage 3313 #18-03HC-X well.

Failure to close the pit prior to the expiration date shall result in a monetary penalty in accordance with K.A.R. 82-3-602(a).
