Dear Sir or Madam:

This letter is to inform you that you have been granted an extension of time to close the workover pit associated with the Studer 2-1 well.

The pit was permitted on September 9, 2012. Workover pits must be closed within 90 days after workover operations cease. According to your extension request letter, additional workover operations are necessary. This extension will expire on **January 12, 2016**. We urge you to make every effort to close these pits within this time frame. Extension of the pit closure time frame automatically extends the time period for filing the closure of surface pit form, but not the time period for filing the waste transfer form (CDP-5).

*Failure to close the pit or request an additional extension prior to the expiration date shall result in a monetary penalty in accordance with K.A.R. 82-3-602(a). An additional pit extension may be renewed upon request, but **no pit permit extension shall be extended beyond six months after the original deadline.***

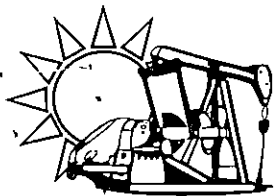
