This letter is to inform you that you have been granted an additional extension of time in which to close the drilling pits associated with the Spangenberg 35-3 well.

Failure to close the pit prior to the expiration date shall result in a monetary penalty in accordance with K.A.R. 82-3-602(a).

An additional pit extension may be renewed upon request, but no pit permit extension shall be extended beyond six months after the original deadline.

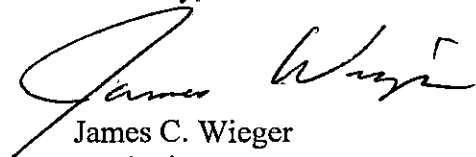
