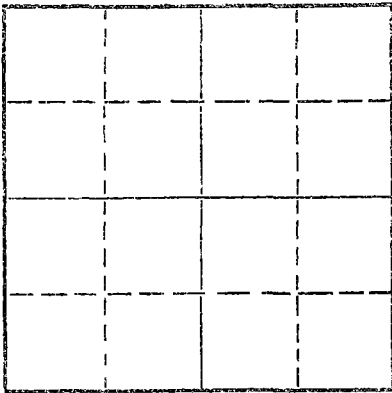

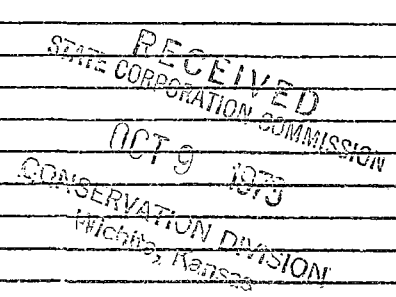

Checked bottom, ran sand to 3800' and dumped 5 sacks of cement. Loaded hole, shot pipe at 3065', 2978', 2824', pulled 59 joints of 5 1/2" casing. Set 10' rock bridge at 524' and dumped 10 sacks of cement, fluid was coming up hole. Dumped 5 yards ready mix.
