Dumped sand to 3800' and 4 sacks cement. Shot casing at 3200' and 3100'. Pulled 97 joints of 4-1/2" casing. Allied squeezed well with 3 sacks hulls, 15 sacks gel, released plug and pumped 150 sacks 60/40 pozmix cement with 3% calcium chloride. Maximum pressure was 200 psi and shutin 50 psi.
