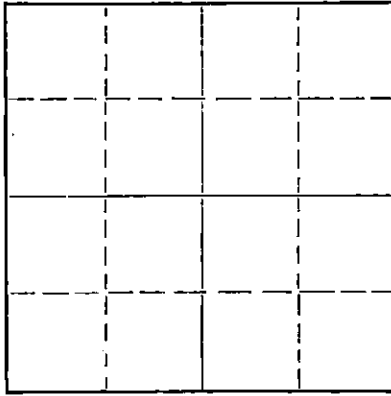

ran 5 more sacks of cement to base of cellar.
