This letter is to notify you that the Conservation Division is in receipt of your plugging proposal, form CP-1, for the above-captioned well.

Your CP-1 has been reviewed by the Conservation Division central office for completeness and to verify license numbers. The plugging proposal will now be forwarded to the district office listed below for review of your proposed method of plugging.

Please contact the district office for approval of your proposed plugging method at least at five (5) days before plugging the well, pursuant to K.A.R. 82-3-113 (b). If a workover pit will be used during the plugging of the well it must be permitted. A CDP-1 form must be filed and approved prior to the use of the pit.

The Conservation Division's review of form CP-1, either in the central or district office, does not include an inquiry into well ownership or the filing operator's legal right to plug the well.

This notice in no way constitutes authorization to plug the above-captioned well by persons not having legal rights of ownership or interest in the well. This notice is void after ninety (90) days from the above date.

Current Commission Regulation K.A.R.82-3-111 states that an operator must either (1) plug the well or (2) give notice of the temporary abandonment on the prescribed form (CP-111) to the K.C.C. within 90 days after operations have ceased on the well. These measures are prescribed by the K.C.C. to protect the ground water and prevent pollution.

The above well was found as a result of a recent lease inspection. According to our records this well has not been plugged and a CP-111 has not been filed.

Due to the amount of time that we feel that this well has been abandoned a temporary abandonment application will not be approved. This letter serves as notice that the above described well must either be plugged or returned to service within 60 days from the date of this letter. Please contact the Dodge City Office to exercise your option to either plug or return this well to service.

If you wish to contest this action, please send your written request for a formal conference with the district supervisor at the appropriate address. In the event a satisfactory agreement cannot be reached at that time, this matter will be referred to the Central Office Legal Staff for further handling.
