Date and hour plugging is desired to begin Nov. 9, 1943

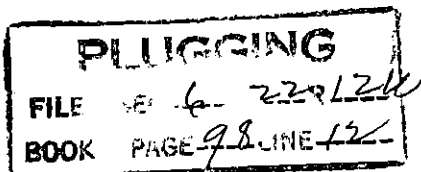
