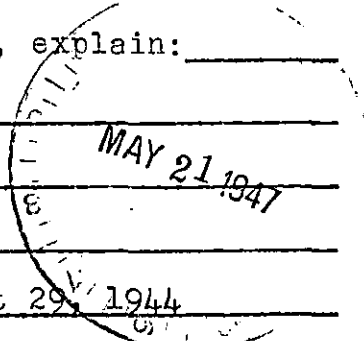

As you will note, we have filled in the Application, taking the information from the file, so will you please sign same and return to us at your earliest convenience.

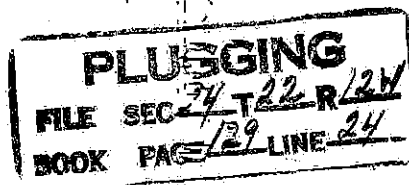
