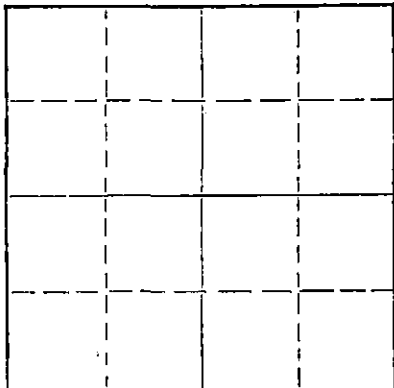

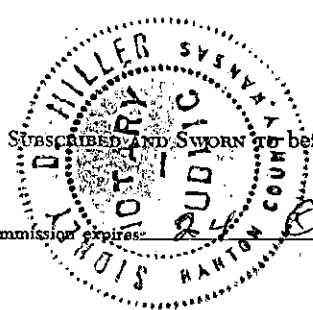
Made bottom hole plug back with sand to 4100'. Mixed and ran 5 sacks cement thru dump bailer.
