Pulled tubing, ran tubing. Got down to 853'. Allied pumped 250 sks and 200 lbs hulls. No cement to surface. Tubing was hung up. Allied ran wireline down backside to 370'. Backed tubing off got 214', 7 joints left 21 joints in hole. Ran tubing back in. Got down to 370'. Allied had to get more cement. Circulated with 75 sks & 200 lbs. of hulls.
