After several tests, none of which showing oil in commercial quantities, hole was plugged back to PBTD 3461 and tested, 1 BWFH, 3/4 BOPH Acidized with 500 gal., max. pressure 700 lbs. per inch. Well then tested 2 BWFH, 3/8 BOPH. Cement was then drilled to PBTD 3463' and tested 1 1/2 BWFH, 1/8 BOPH. As oil in commercial quantities was not encountered, abandonment approval is requested.

Date and hour plugging is desired to begin Oct. 20th., 1943
