If cement or other plug were used, state the character of same and depth placed, - from feet to feet each set rigged up unit, ran down to find T.D. Got down to 800'. On way back out of hole got hung up at 300'. Casing fell down 50'. Shut down to fish tools. Ran over shot to fish 5 1/2" casing. Pulled 300' of casing out. Ran open end 2 3/8" tubing. Got down to 740'. Allied pumped 225 sks down, no cement to surface. Pulled tubing, ran tubing to tag top of cement. Tagged 300'. Ran in 10 joints Allied pumped 60 sks to circulate tubing. Topped off well.
