Dear Sir or Madam:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the Moeder 1-21 well.

The*original 365 days for closure expired on 03/28/2017. This extension will expire on 08/11/2017. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the closure of surface pit form, **but not the time period for filing the waste transfer form (CDP-5).**

*Failure to close the pit or request an additional extension prior to the expiration date shall result in a monetary penalty in accordance with K.A.R. 82-3-602(a). An additional pit extension may be renewed upon request, but **no pit permit extension shall be extended beyond six months after the original deadline.***

Kathy Haynes:

We received a notice of a violation of failure to submit a completed CDP-4 for the Moeder 1-21 in Ellis County, API # 15-051-26822-00-00 located in the NESWSWNW Sec. 21-13S-17W. Due to the fact that the drilling pit was dug in a draw in the pasture and all the water coming from the hills in the pasture runs across the well location and into the drilling pit. The pit has never been dry enough to backfill for over a year. At this time we are asking for a 90 day extension of the Surface Pit Closure and in that length of time we hope the pit will be dry enough to backfill and we will immediately backfill the pit and submit a CDP-4 on KOLAR.
