Vincent Oil Corporation is requesting an additional extension to the requirements for pit closure for a reserve pit associated with the above referenced well. By letter dated 12/8/2016 we requested a 120 day extension beyond the original required closure date of December 7, 2016. By letter from the KCC dated December 9th, 2017 Vincent Oil Corporation was given a 90 day extension to close the pit or file for an additional extension. Such closure or request for extension would need to be accomplished by March 7th 2017.

Since that extension date our dirt contractor has done additional work at the site, but an inspection of about a week and a half ago (on or about February 13. 2017) showed that the site still needed some additional drying before final closure. Per our telephone conversation of this date Vincent Oil Corporation is requesting an extension to the requirements for pit closure for a reserve pit associated with the above referenced well. We are requesting a 120 day extension beyond the original required closure date of December 7, 2016.

We have made several attempts to complete the pit closure, as evidenced by the attached invoices for work performed at the site, but have been unsuccessful.
