Reason for Investigation:

Troy Russell, District #3 Supervisor, sent a request to investigate the status of well #7 on the Ermel E lease.

Problem:

Abandoned well listed on RBDMS.

Findings:

I went to the Ermel E lease in the morning on 4/10/2017. I went to the location where well #7 was suppose to be located. No well was present above surface at this location. I used a metal detector and walked an area approximately 300' around where well #7 was suppose to be located. No evidence of a well was found. During my investigation I did find three (3) wells further North on the property. These wells are approximately 1000' further North of the location given for well #7. I GPS'd all three (3) of the wells and the GPS information is attached to this field report. I took pictures of all three (3) of these wells and the photos are attached to this field report. After returning to the office I tried to match these three (3) wells to wells listed on RBDMS, however, there is no wells listed on RBDMS for those locations.

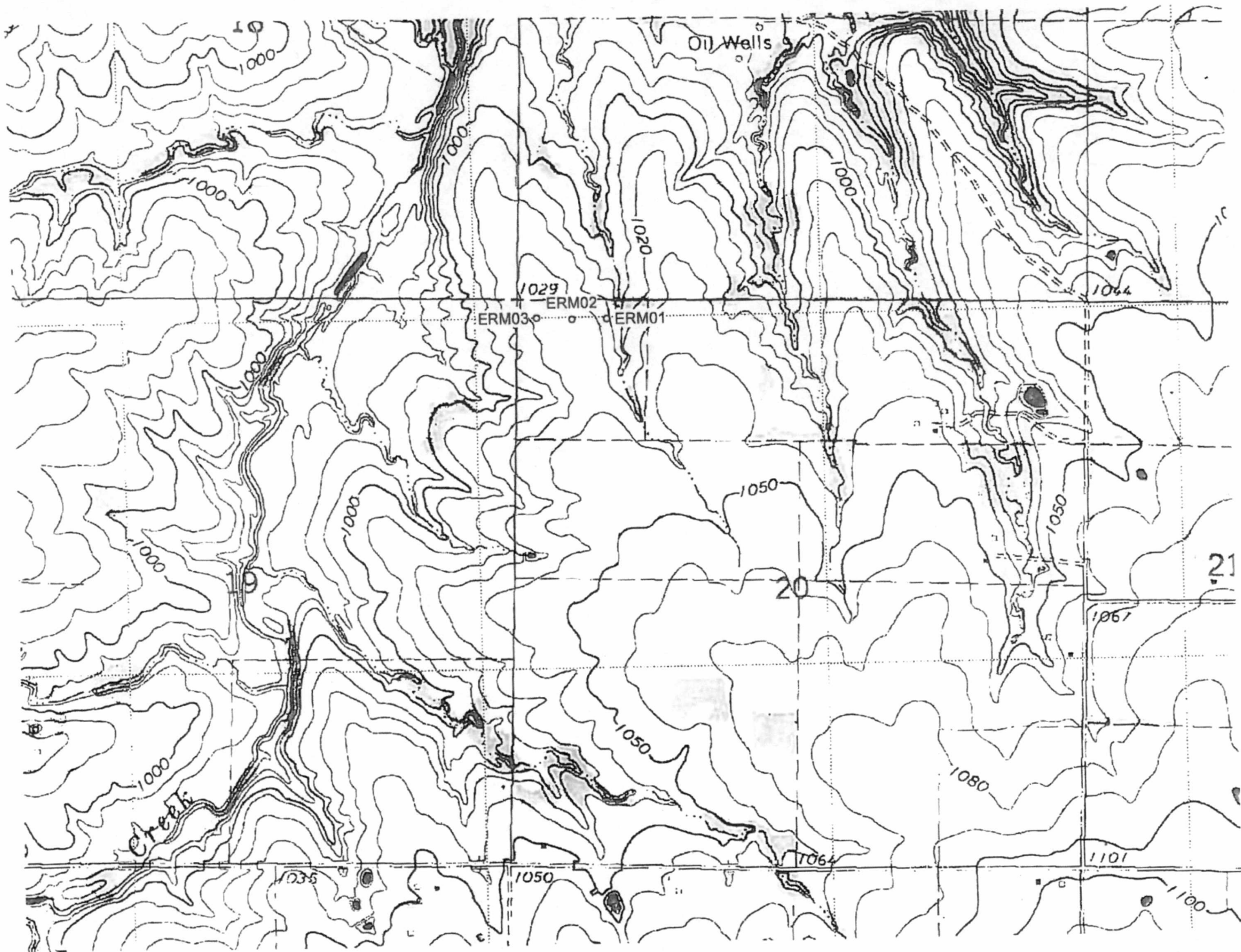
