Dear Kathy,

You are receiving this letter to inform you that Weigel Oil Company, LLC in Gorham, Kansas has purchased the Booth B lease in Russell County, S/2 NE/4 of Section 29, Township 11 South, Range 15 West, from Empire Energy L&P LLC effective date was October 9, 2017. The Booth B #3 well API # 15-167-06308-001 was currently not producing when Weigel Oil Company LLC took over the lease due to a mechanical failure (casing leak) and needed to be fixed to restore production. Weigel Oil Company LLC has fixed all mechanical problems and now ready to put the pump back on production as of November 14, 2017. My plan is to work on the Booth B4 well API #15-167-23102 next to make a salt water disposal well. I did MIT the well December 2017 to 300# and held solid so I know the casing is good. Due to lack of production in 2017 Weigel Oil Company LLC needs to validate the original lease agreement dated June 3rd, 1928. I'm having trouble with 2 out of the 11 royalty owners that are stating they want both wells to be plugged. We are currently trying to resolve the problem but might have to push the issue into court to settle an agreement. This has taken more time than anticipated and I apologize for any delays or inconvenience. I am requesting an extension on the pit application #15-167-23102-00-00 for the Booth B#4 well until I get the title work cleared up. I will need this pit to be left open to re-work the well or to plug the well which will be decided after the title issue is resolved.
