A tract in the East Half of the Northwest Quarter (E/2 NW/4) of Section Ten (10), in Township Twenty-three (23) South, of Range Sixteen (16), East of the Sixth Principal Meridian, more particularly described as follows:

Beginning at a point on the Southwest corner of the East Half of the Northwest Quarter (E/2 NW/4) of Section Ten (10), thence North along the West line of the E/2 NW/4 section 10 to a point at the Northwest corner of the E/2 NW/4 Section 10, thence East along the North line of the E/2 NW/4 Section 10, to a point which is on the Westerly right-of-way line of the Coffey County road, FAS 1473, thence Southwesterly along the Westerly right-of-way line of the Coffey County road, FAS 1473 to a point of intersection with the South line of the E/2 NW/4 of Section 10, thence West along the South line to the point of beginning, containing 38.9 acres, more or less.

3. Oil and gas lease dated December 16, 1980, by and between Marjorie M. Sutherland and her husband, Theodore Norvin Sutherland, lessors, to D.J. Schmidt, lessee, and recorded on January 23, 1981, in Book 25, Oil and Gas, Page 500-501 of the Register of Deeds in Coffey County, Kansas, to wit:

4. Oil and gas lease dated October 6, 1978, by and between L.R. Hannen, Attorney-in-fact for Carmean Wood, lessor, to Mark Haas, lessee, and recorded on October 6, 1978, in Book 22, Oil and Gas, Page 241-243 of the Register of Deeds in Coffey County, Kansas, to wit:

The Southwest Quarter (SW/4) of Section Ten (10), and the West Half (W/2) of the Southeast Quarter (SE/4) of Section Ten (10), Township Twenty-three (23), Range Sixteen (16), excepting a tract of land beg. at the Southeast corner of the West Half of the Southeast Quarter of Section Ten (10), Township Twenty-three (23), Range Sixteen (16), thence North about 107 rods to the center of the Neosho River, thence Southwest down said center of said Neosho River to South line of Section, thence East of Section line about Thirty-six (36) rods to place of beg. containing 20 acres more or less, also except tract deeded to Coffey County, Kansas
