ASSIGNMENT AND BILL OF SALE OF OIL AND GAS LEASES

FOR THE SAME CONSIDERATION, Assignor does hereby GRANT, BARGAIN, SELL, CONVEY, ASSIGN, TRANSFER, SET OVER AND DELIVER unto the Assignee, effective upon execution of this instrument, all of the Assignor's right, title and interest in and to all personal property, oil or gas, improvements, lease and well equipment, permits, licenses, servitudes, rights of way (including, but not limited to, all wells, casing, tubing, tanks, pump jacks, boilers, separators, fixtures, machinery, injection facilities, salt water disposal facilities, compression equipment and all other equipment, processing plants, gathering systems, pipelines, power lines and other appurtenances) situated upon or used or held for future use in connection with the exploration, development, or operation or maintenance of the properties described above, or any unit or units in which part or parts of the properties described may be included or in connection with the production, treating, storing, transportation or marketing of oil, gas, and other minerals produced from or allocated to the oil and gas leases described herein.

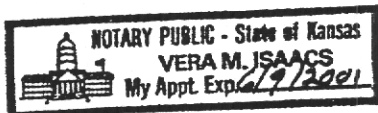
