SALT WATER DISPOSAL WELL AGREEMENT

THIS AGREEMENT made and entered into this 4th day of April, 2003, by and between Tom W. Ahrens and Rosa M. Ahrens, husband and wife, hereinafter referred to as "Lessors", and Leon Pfeifer, hereinafter referred to as "Lessee".

WITNESSETH:

WHEREAS, Lessors are the owners of the following described land situated in Logan County, State of Kansas, to-wit:

The West Half of the Northwest Quarter of the Northwest Quarter (W/2 NW/4 NW/4) of Section Thirty-three (33), Township Twelve (12) South, Range Thirty-three (33) West of the 6th P.M., Logan County, Kansas

AND WHEREAS, there is an existing dry oil test hole located on the above described land and Lessee desires to utilize the same for the disposal of salt water for purposes of enhancing secondary recovery on adjacent lands and for the disposal of salt water produced from lands in the general vicinity.

NOW THEREFORE, for and in consideration of the sum of Six Hundred and No/100 Dollars (\$600.00) paid by Lessee to Lessors and in consideration of the covenants and agreements herein contained, it is stipulated and agreed between the parties hereto as follows:

1. Lessors do hereby demise, lease and let exclusively unto Lessee the above described land for salt water disposal purposes, and grant unto Lessee the right to drill a well or wells for the disposal of salt water produced from said land and other wells located in the vicinity thereof, or to convert any other well(s) located upon said land which is (are) not a commercial producer of oil or gas for use as a disposal well(s) for the disposal of water produced from lands in the same general vicinity.

2. It is expressly agreed that all salt water and other like substances disposed into said well or wells shall be transported from receiving tanks into the salt water disposal well. Lessee agrees to construct protective dikes around said receiving tanks of the salt water disposal well. The receiving tanks shall be located adjacent to the salt water disposal well.

3. Lessors further grant unto Lessee full rights of ingress and egress at all times.

4. Lessee shall have the right at any time to remove from any salt water disposal well or wells, and from said land, any and all casing, pipe, materials, lines, equipment and other personal property used in connection with any salt water disposal well(s) upon said land.

5. It is understood and agreed that in the event salt water or other like substances are disposed into said salt water disposal well(s) located upon said land from a well or wells located on lands and/or leases in which Lessors are not a mineral or royalty interest owner and located off the above described land, then Lessee shall pay or tender to Lessors Six Hundred and NO/100 Dollars (\$600.00) per year per lease in advance. The date hereof shall be the anniversary date upon which annual rental for disposal of salt water from wells or leases shall be paid, and the first annual rental due hereunder for the disposal of water from any such well or wells or lease(s) shall be in the amount sufficient to pay the proportionate part of the annual rental due from the commencement of such disposal of waters until such anniversary date and one year's annual rental therefor in the future. Lessors direct that any and all rentals provided for in this agreement shall be paid or tendered to Lessors unless and until Lessee is furnished with further directions in writing with respect thereto, or Lessee has been furnished with a certified copy of any instrument or proceeding which has the legal effect of changing the parties to whom such rentals shall be due and payable. It is further agreed with reference to the payment of rentals hereunder that in the event of failure by Lessee or his assigns to pay any rental hereunder when due, this agreement and lease shall not terminate until thirty (30) days after Lessors shall have given Lessee or his assigns written notice by mail of such failure and payment of such rental is not made within said thirty (30) days.

6. This agreement shall continue in force and effect for so long as Lessee requires the use of any well or wells upon said land for salt water disposal purposes, provided that the rentals, covenants and agreements herein contained shall be paid and kept.

7. It is understood and agreed that Lessee shall have the right to terminate this lease at its election by giving Lessors thirty (30) days notice in writing of such intent to terminate.

8. Lessee shall pay or tender to Lessors for any and all reasonable damages to said land caused by operations of said disposal well or wells.

9. The terms, conditions, covenants and provisions hereof shall extend to and be binding upon the parties hereto, their heirs, executors, sub-lessees, assigns and successors in interest.


