



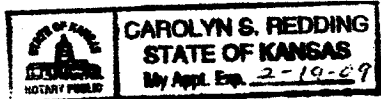
I, Larry J. Putnam, of legal age and sound mind,
