ASSIGNMENT AND RECONVEYANCE OF OVERRIDING ROYALTY INTEREST

KNOW ALL MEN BY THESE PRESENTS:

That Edith A. Ward, hereinafter referred to as Assignor, for and in consideration of the sum of Ten and no/100 Dollars cash in hand paid and other good and valuable consideration, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, reconvey, transfer, and reassign to Michael S. Holland - an undivided 1/8th interest; Catherine Holland - an undivided 1/8th interest; C & R Oil, Inc. - an undivided 3/8ths interest; and R. L. Schulte, Inc. - an undivided 3/8ths interest, respectively, all of assignor's 3/64ths of 7/8ths Overriding Royalty Interest in and to the following oil and gas leases:

1. Oil and Gas Lease dated October 31, 1981, and recorded in Book 160, page 809-10, from Earl Ward, et.al., to Steven Ward, covering:

2. Oil and Gas Lease dated October 31, 1981, and recorded in Book 160, page 811-2, from Barbara Jane Ward, Administratrix of the Estate of Donald Eugene Ward, Dec., to Steven Ward, covering:

THE NORTH HALF OF THE NORTHWEST QUARTER (N $\frac{1}{2}$ NW $\frac{1}{4}$ ) and THE SOUTHWEST QUARTER OF THE NORTHWEST QUARTER (SW $\frac{1}{4}$ NW $\frac{1}{4}$ ) OF SECTION 4, TOWNSHIP 15 SOUTH, RANGE 13 WEST OF THE SIXTH P.M., Russell County, Kansas.

It is the express intent of the parties that Assignor's 3/64ths of 7/8ths Overriding Royalty Interest be reassigned to the current working interest owners in their proportionate shares set forth above and that their proportionate share of the Overriding Royalty Interest be reunited and recombined into working interest under said oil and gas leases.

This instrument shall have no effect on the 1/64th of 7/8ths Overriding Royalty Interest currently owned by Lynda W. Ward which will remain in full force and effect.
