No person dealing with the Trustee shall be obligated to see to the application of any money or property delivered to the Trustee or to inquire into the Trustee's authority with regard to or the propriety of any transaction. Only the Trustee shall be fully liable for any improper or unauthorized act, and shall indemnify and hold harmless any person relying upon such Trustee's authority.
  - c. None of the powers given the Trustee herein are given by way of limitation, and each is supplementary to the powers granted elsewhere in the Trust Agreement, or otherwise by law. Furthermore, the Trustee or Successor Trustees shall have all the powers granted under the Kansas Uniform Trust Code, as it now exists or may hereafter be amended.
  - d. Should any Trustee or Successor Trustee named above die, resign, or otherwise become unable to serve as Trustee, any third party in regards to ascertaining or determining the authority of any Successor Trustee to act as Trustee need only reply upon the presentation by such Successor Trustee of a copy of this Certification of Trust along with a copy of any one or more of the following documents:
    - i. A death certificate of any predecessor Trustee; or
    - ii. A resignation certificate of any predecessor Trustee; or


