

1. That she is a resident of Arkansas City, Cowley County, Kansas residing at 1520 North 23rd Street, Arkansas City, Kansas 67005.
2. That she is the surviving spouse of Donald Gene Jenkins, Sr., who passed away on the 10th day of June, 2012, a resident of Arkansas City, Cowley County, Kansas.
3. That at the time of Donald Gene Jenkins, Sr.'s. death, he was the holder of an operator's license issued by the Kansas Corporation Commission, and which authorized the Decedent to operate oil and gas wells within the State of Kansas.
